## **ANNUAL LICENSE FEES**

All Foundations must be renewed within 30 days from the date of Registration every year:

- (a) \$200 if paid within 30 days;
- (b) Plus \$50 for an extension of renewal (however written reason must be submitted by Foundation Council member for extension);
- (c) Plus \$150 for reinstatement to Register after extension of renewal was granted;
- (d) \$500 to restore to register once no extension was granted.
