ANNUAL FEES

Annual Licence is due and payable on or before the anniversary date of the Company's registration.

Any Company that fails to pay the annual fee by or before the due date shall be subject to Government penalties as follows:

- **A grace period of thirty days after the due date;**
- **Penalty fee of US\$115 for annuals paid within the first six months after due date;**
- **Penalty fee of US\$250 for annuals paid after six months but within twelve months of due date;**
- **Penalty after twelve months of due date - Struck off Company's Register.**

• If company was not renewed for two years it will be struck off from the registry (Registry struck off dates: 31st July and 31st January – struck off date depends on company incorporation date). Reinstatement Fee after company is struck off is US\$200.
